SALIENT FEATURES OF THE DIRECT RECRUITMENT PROCESS FOR FILLING UP OF THE POST OF ASSISTANT SECURITY OFFICER (A) [POST CODE: DR/01] IN THE LEVEL '6' OF PAY MATRIX IN BHABHA ATOMIC RESEARCH CENTRE, TROMBAY, MUMBAI AND BARC FACILITIES (VIZAG), VISAKHAPATNAM, ANDHRA PRADESH AGAINST ADVT. No. 2/2019(R-II)

AND SELECT PANEL

- 1. Recruitment process was initiated for filling up vacancies in the post of Assistant Security Officer (A) in the Level '6' of Pay Matrix [Group 'B' (Non-Gazetted)] by publishing Direct Recruitment Advertisement No.2/2019 (R-II) in the Employment News and other National/Local newspapers. The detailed advertisement was displayed on BARC's websites viz. <a href="www.barc.gov.in">www.barc.gov.in</a> and <a href="www.recruit.barc.gov.in">www.recruit.barc.gov.in</a>. The applications were called 'ONLINE' during the period from 16.11.2019 to 06.12.2019.

## 3. **Examination Synopsis:**

- Examinations were conducted in two stages viz. Level-1 Physical Test (qualifying for Written Test) and Level-2 Written Test for total 75 marks.
- The Level-1 Physical Test was conducted on January 18, 19, 20, 21, 22, 25, 27, 28 and 29, 2021 at PTAA Sports Complex, Opp. New Training School Complex, Anushaktinagar, Mumbai-94.
- Document verification of candidates qualified in Physical Test was done on the same day of their physical test date.
- Result of Physical Test i.e. 'No. of candidates appeared and no. of candidates called for Written Test' was displayed on BARC's websites and intimated to the candidates by email and SMS.
- Written Test was conducted on March 21, 2021 at Atomic Energy Junior College, Anushaktinagar, Mumbai-94.

## 5. **Selection Criteria**:

Physical Test: it was only qualifying criteria to appear in Written Test.

<u>Written Test :-</u> it was carried out on the basis of negative marking i.e. for each and every wrong answer  $1/4^{th}$  (0.25) marks assigned to the Question were deducted from total marks. In cases where there is tie in total marks, candidate who has scored higher marks in 'Report writing' section has been given preference.

The total marks scored by the candidate in the written test was decided to be taken as the criteria for empanelment. Accordingly, following criteria for various categories of candidates has been adopted for empanelment:-

Category Cut-off percentage	
UR/General	46 % and above
OBC	45 % and above
SC	32 % and above
ST	33 % and above
EWS	34 % and above

Candidates have been empanelled in the Select List based on the number of vacancies advertised in each category and remaining have been placed in the Wait List.

The selected candidates should note that the panel is provisional and does not confer on him/her any right to appointment unless he/she satisfies the Recruitment Norms as per the advertisement and pass the prescribed medical examination. If, it is found that any candidate is not fulfilling the Recruitment Rules/Norms, his/her candidature is liable to be terminated/cancelled at any time.
- 8. Appointment of candidates will be subject to availability of vacancies and other related Govt. Orders viz. receipt of satisfactory/clear verification of Character & Antecedent Reports, medical fitness certificate (issued by BARC Medical Officers), production of original documents such as educational qualification certificates, No Objection Certificate, Discharge Certificate and verification of Caste Certificate/Non-Creamy-layer Certificate, Caste Validity Certificate, Income Certificate (in respect of EWS) etc. wherever applicable.
- 9. Candidates are liable to serve in any constituent unit of Department of Atomic Energy in any part of India.
- 10. The wait list shall be operated only in the event of occurrence of a vacancy caused by non-joining of the candidate from the select list within the stipulated time allowed for joining the post or where a candidate joins the post but resigns or dies within a period of one year from the date of joining, if a fresh panel is not available by that time. Waiting list should however, not be operated beyond one year or after notifying any such recruitment whichever is earlier.
- 11. Records of the non-selected candidates shall not be preserved beyond 06 months from the date of publication of Select List.
