2. EDUCATIONAL QUALIFICATIONS & EXPERIENCE : -

Note:

1. The upper age limit is also relaxable suitably in cases of certain other categories such as Children/Family member of those died in 1984 riots, Ex-servicemen, repatriates, retrenched employees, Sports persons, widows, divorced women and women judicially separated from their husband and who are not remarried etc. as per extant rules.

5. METHOD OF SELECTION :-

Selection will be made on the basis of initial screening and then qualifying in written examination. All tests will be held in Mumbai.

7. HOW TO APPLY :-

1. Details of online applications are available in website www.barcrecruit.gov.in
2. Persons working under the Central / State government, Public sector undertakings should submit their "NO OBJECTION CERTIFICATE" at the time of written test
3. Application will be accepted **online** only.

8. GENERAL CONDITIONS :-

- a. Only screened-in applicants will be called for written test.
- b. SC/ST outstation candidates will be paid to and fro travelling allowance of second-class Railway fare by the shortest route (subject to production of tickets) as admissible under the Rules.
