- PRICE:** Offer should be including the entire scope of work (Material supply, installation packing and forwarding, transportation, GST etc.). Max possible break up price should be given in the offer.
- FREE ISSUE MATERIAL:** No free issue material will be provided by BARC.
- QUALITY:** The quality of the supplied material should be as per the technical specification.
- VALIDITY:** Price should be valid throughout the contract period.
- DELIVERY PERIOD:** The job is to be completed within **02 month** from the date of **ISSUE** of the order. Any delay which is liable to the contractor is liable for penalty @ 0.5% per week (5% maximum) to be imposed on the contractor. For extension in delivery period, vendor should ask for extension in writing before completion of work order and with reasonable and acceptable reason.
- INCOME TAX:** Income Tax @ 2% and surcharge on tax as applicable shall be deducted from vendor's bill.

7. **PAYMENT:** 100% including taxes after receipt of the unit at our site, final acceptance of the total job and submission of the following documents:
- Delivery Challan.
 - Advance Stamped Receipt and ECS details.
 - Original Bill that includes GST Number, PAN Number.

8. **TERMS AND CONDITIONS:**

Note: [Reference: (2/Misc-9/Lgl/2001/92 dated April 30, 2001, BARC)]

- a. **Confidentiality:** No party shall disclose any information to any third party concerning the matters under this contract generally. In particular, any information identified as “Propriety” in nature by the disclosing party shall be kept strictly confidential by the receiving party and shall not be disclosed to any third party without the prior written consent of the original disclosing party.



- c. Hand delivered quotation or quotations will not be entertained in our office.


