Sealed quotations are invited on behalf of the President of India by Head, RTD, for Execution of various jobs related to Refuelling Technology Division as per specification NCKRTD18 at Hall7. for the period of 12 calendar months. This work is to be executed at the purchaser's premises at Engg. Hall No. 7, BARC. Bidder can visit the premises to assess the quantum of work involved with prior intimation and permission of the purchaser.

General Notes:

- 1) The work at purchaser's site can be executed **only on working days** (Monday to Friday) between **0800hrs and 1800 hrs**. Working on holidays is not permitted.
- 2) The bidder shall comply with all the necessary security requirements for entry into BARC premises. All the workers shall have valid Police Verification Certificate (PVC)
- 3) The bidder shall provide **three unskilled** man power for execution of job.
- 4) The bidder shall take all the necessary safety precautions during work and they shall be responsible for any damage or accidents. No compensation in any case will be paid by the Department to the bidder.
- 5) The work shall be subject to inspection by the purchaser or his authorized representative. Work shall be conducted under their supervision and to the full extent of satisfaction.
- 6) The quotation must reach Head, RTD, Engg.Hall-7 **latest by 11/06/2018**. Quotations will be **opened on 14/06/2018 at 2.30 pm**.
- 7) The above mentioned reference no. and date and time of opening of bids must be clearly mentioned on the sealed envelope containing the quotation.
- 8) The quotations have to be send by **speed post**. Hand delivered quotation will not be entertained.
- 9) The work shall be completed within **12 calendar months** from the receipt of work order.

- 10) Payment will be made yearly as per govt. rules, after the completion of the assigned work to purchaser's satisfaction against submission of original bill in triplicate and advance stamped receipt.
- 11) Income tax @2% and GST as applicable will be deducted from the bill. Taxes if applicable shall be paid as per government rates.
- 12) Bidder shall mention their PAN and VAT/GST Nos. in the quotation.
- 13) The offer shall be kept open for acceptance for a minimum period of 45 days from the date of opening of the quotation.
- 14) Head, RTD reserve the right to accept/reject any or all the quotations received without assigning any reason whatsoever.
- 15) The bidder shall furnish the detailed information regarding whether an ex-employee of BARC is working in their organization or whether any of their relative is working in DAE/BARC or whether he/she is an ex-employee of DAE/BARC. In case of absence of such information, or wrong information the quotation or contract is likely to be rejected or cancelled.

CONFIDENTIALITY CLAUSES:

I. Confidentiality:

No party shall disclose any information to any third party concerning the matters under this contract generally. In particular, any information identified as "Proprietary" in nature by the disclosing party shall be kept strictly confidential by the receiving party and shall not be disclosed to any third party without the prior written consent of the original disclosing party.

This clause shall apply to the sub-bidders, consultants, advisers or the employees engaged by the party with equal force.

II. "Restricted information" categories under Section 18 of the Atomic Energy Act, 1962 and "Official Secrets" under Section 5 of the Official Secrets Act, 1923:-

Any contravention of the above-mentioned provisions by any bidder, sub-bidder, consultant, adviser or the employees of a bidder will invite penal consequences under the aforesaid legislation.

III. Prohibition against use of BARC's name without permission for publicity purposes:-

The bidder or sub-bidder, consultant, adviser or the employees engaged by the bidder shall not use BARC's name for any publicity purpose through any public media like Press, Radio, T.V. or Internet without the prior written approval of BARC.

Scope of work and Technical Specification

Item : Execution of various jobs related to different facilities of Refuelling Technology Division as per specification NCKRTD18 at Hall-7.


1. **Scope of work:** Jobs related to different facilities of Refuelling Technology Division as per specification NCKRTD18 at Hall-7.

2. **General Description of the job:**

Jobs related to different facilities involves periodically cleaning of Fuelling machine components, housekeeping of area around Fuelling machine & PFBR, removal of unwanted material from shopfloor after fabrication work, helping divisional technicians for maintenance of test facilities like FM Ram test set up, separator test set up, Hydraulic oil test set up.

The various workshop job involves movement of various support structure as and when required, clearing of space for storage of the components, lifting of the material from stores to site, movements of equipment's like motor, pump, pipe, angle, beam, channel, M.S. chequered plates, fasteners, nut and bolts, scaffolding, ladders, gas cutting set, welding machine, plasma cutting machine, grinder, drilling machine from one place to another at site as per the requirement given by the purchaser.

Three unskilled labourer are required for 12 calendar months to execute above work. The necessary safety precautions shall be taken by the contractor during work and the contractor shall be fully responsible for any damage or accidents. No compensation in any case will be paid to the contractor.
