### (1) SCOPE OF WORK: -

- (a) Repair and Calibration of different type of gas sensors for Gas detectors system = 51 Nos.
- (b) During calibration if any sensor or controller is damaged, replacement of the sensor or controller is in the scope of the vendor.

- (c) Replacement of one NOX and one HF gas detector compatible of existing controller card of RK-220.
- (d) Testing canister should be provided by the vendors and should have proper validity certificate for the contents inside the canister.
- (e) After completion of the work, proper documentation & report of the work is to be submitted by the vendor
- (f) Repair and calibration of sensors will take place in the presence of BARC personnel only after installation.

- (3) **PRICE:** Offer should be including the entire scope of work (calibration, taxes, packing and forwarding, transportation). Max possible break up price should be given in the offer, extra job, if any, will be on pro rata basis only.
- (4) WARRANTY: Minimum 18 month after testing in BARC.
- (5) **TESTING:** Gas sensor at BARC after calibration will be tested. All relevant test certificates and documents have to be submitted at the time of hand over. Testing canister should be provided by the vendors and should have proper validity certificate for the contents inside the canister.
- (6) VALIDITY: Price should be valid throughout the contract period.
- (7) COMPLETION PERIOD: The job is to be completed within 2 months from the date of receipt of the order any delay which is liable to the contractor is liable for penalty @ 0.5% per week (5% maximum) to be imposed on the contractor.
- (8) IMPORTANT NOTE:

Vendor/Contactor should have pre-cleared Security Vetting of his company/Firm as per BARC Security rules.

All workers/labors of the Vendor's/Contractor's Company/Firm should have valid PVC not expiring during the tender period (i.e., from the date of issue of this enquiry till completion of job after getting work order).

(9) SAFETY: Party should follow all the safety procedure while working inside BARC. During the execution of the work order party will be responsible for all safety precautions to be maintained in the work area. The party should arrange all the safety appliances. Any injury/damage caused to the contractor's work force during execution of the job for any reason whatsoever shall be the liability of the contractor only. The vendor will be only responsible for any labor related dispute.
