
#### **SPECIFICATIONS**

1. **De-commissioning, De-termination & Recovery for followings fittings and related point wiring and circuits from Main Laboratory Area :**

(a) Faulty Light point wiring & its related circuit along with concealed conduits & related lighting board de-commissioning from the distribution Board & disposal of same up to scrap go-down/store. - **Lab. Site**

(b) 2 x 40 Watts Tube Light Fixture. - **20 Sets**

2. **Wiring for light Points in 3 x 1.5 mm<sup>2</sup> PVC insulated Cu wire (Multi Strand, Flame Retardant Low Smoke) above fall ceiling in PVC conduit as per site requirement with accessories "MDS" Legrand make Mosaic series/ or equivalent. - 05 Pts.**
3. (a) Supply & installation of interated Induction Lamp fitting of 150W. - **05 Sets**  
(b) Provision of Anchor Fastner (Hook) with Minor fabrication i.e. M.S. Plate Anchor fastening for installation of interated Induction Lamp fitting as per site requirement.
4. De-commissioning, De-termination, dismantling & recovery of old existing Power Point Boards & related circuit modification work with supply, installation & related wiring, testing of Multi Socket 6A/ 5 Pin + 16A/ 5 Pin power point board in place of existing damaged Power Point Board in surface in PVC conduit/ PVC casing & capping as per site requirement with accessories "MDS" Legrand make Mosaic series / or equivalent. - **05 Pts.**

### Scope, terms & conditions of Work:

- 2 Delivery & Installation of the items at S63A, South Site, BARC, Trombay, Mumbai-400085. Any delay in completion of order, which is attributed to supplier, will be liable for penalty @ 0.5% per week (max. 5%) to be imposed on supplier.
- 3 Income Tax @2% and surcharge & 3% education cess on tax as applicable shall be deducted from your bill.
- 4 Payment shall be made after the receipt, acceptance of the Items and on receipt of the following documents.
  - (a) Delivery challan in duplicate.
  - (b) Bill in triplicate.
  - (c) Declaration of PAN number & GST registration number.
  - (d) Advanced stamped receipt in favour of Accounts Officer, BARC, Mumbai.
- 5 You may visit the site with prior appointment with the undersigned.
- 6 The undersigned reserves all the rights to reject the tender without assigning any reasons.
- 7 The offer shall be valid for a period of sixty days and in case of placement of the work order, shall remain firm till the completion of the work.

### 8. Confidentiality Condition

No party shall disclose any information, to any third party concerning the matters under this contract generally. In particular, any information identified as "proprietary in nature by the disclosing party shall be kept strictly confidential by the receiving party and shall not be disclosed to any third party without the written consent of the original disclosing party. This clause shall apply to the sub-contractors, consultants, advisers or the employees engaged by the party with equal force.


