Sub: Tender enquiry for supply, fabrication and installation of SS 304L structural barricade above turnstile at AFD

Sealed offers are invited for and on behalf of the President of India for supply, fabrication and installation of SS 304L structural barricade above turnstile at AFD.

Scope of work, terms and conditions are as follows.

Scope of work:

Supply, fabrication & installation of SS 304L structural barricade as per attached sketch --- 1 no.

- i) Overall size of barricade is
Front Elevation: 5110 mm X 710/405 mm
Side Elevation: 3110 mm X 405 mm
- ii) Material: SS 304L
- iii) Main horizontal and vertical support shall be of size 50 X 50 X 3 mm thick square pipe anchored at the walls with SS plate of size 80 X 80 X 6 mm thick with M8 X 50 mm anchored fastener.
- iv) Grill shall be of 25 X 25 X 2.5 mm thick square pipe.
- v) The barricade at front elevation shall be supported on existing 50 X 50 SS square box with the help of 80 X 80 X 6 mm SS plate with M10 nuts & bolts at three locations.
- vi) The barricade at side elevation shall be matched with size 405 mm and anchored at the other side of wall with SS plate of size 80X 80 X 6 mm thick with M8 X 50 mm anchored fastener.
- vii) Total weight of the structural barricade is @ 150kg.

General Technical Requirement:

- 1) All welding by TIG welding.
- 2) All surfaces shall be mirror polished, including the weld areas.
- 3) Supplier shall carry out actual measurements at site and suggest deviations if any to make necessary changes if required.
- 4) Supplier shall prepare its own fabrication drawing as per actual site condition and shall get it approved from the purchaser before commencement of work.
- 5) All fabrication work shall be carried out as per approved drawings only.
- 6) All material supply is in the scope of supplier. Supplier shall use all relevant IS standard material for this work. Material testing reports (Chemical, Mechanical etc.) from Govt. approved labs shall be submitted for approval. Material identification and stamping shall be witness by departmental representative. There is no Free-Issue Material (FIM).
- 7) Supplier shall have qualified welders to perform this work.
- 8) In case of any technical doubt, supplier shall contact the purchaser for clarifications.

- 9) Supplier shall have to arrange for welding m/c along with all consumables required for this work.
- 10) Gas cutting, arc welding, grinding work etc. shall be carried out with utmost care. Supplier shall follow all safety measures while carrying out such work.
- 11) Burs, sharp edges, projections etc. caused due to cutting, welding etc. shall be removed to maintain smooth surface.

Terms and conditions:

- 1) Work completion period shall be **60 days** from the date of issue of this work order.
- 2) Taxes, if any, shall be specified separately.
- 3) Necessary TDS Exemption certificate shall be issued by the department, if required. For this 15 days advance intimation is required from your end.
- 4) The offer should **clearly/ separately** mention the basic cost of supply, GST etc.
- 5) The offer should also contain the work completion period.
- 6) Supplier shall give guarantee for a minimum period of one year for the workmanship after execution of work.
- 7) Any delay which is attributable to the supplier in executing the work is liable for penalty @ ½% per week (max 5%) to be imposed on the contractor.
- 8) In case of delay in work completion, supplier may send request letter to the purchaser for extension in work completion period with proper justification for delay in work. The purchaser may or may not give extension with or without penalty depending on the justification for delay.
- 9) 100% payment will be arranged after satisfactory completion of work at AFD and on production of bills in triplicate, advance stamped receipt, guarantee certificate.
- 10) Supplier shall obtain Police verification certificate for all his employees engaged in the work.
- 11) Supplier shall take all safety precautions while working in the department and shall be responsible for any incident happened in the department related to this work. For elevated jobs proper Safety Belts shall be used by all workers.
- 12) Income Tax @ 2%, surcharge on IT & Education cess as applicable shall be deducted from the bill.
- 13) Supplier must furnish their **PAN no. & copy of GST Registration Certificate.**
- 14) The upkeep of area is the responsibility of contractor. Any unwanted or extra materials shall be kept at designated area which will be shown by departmental supervisor.
- 15) **Sealed offer shall reach on or before 21/06/2018 by registered/ speed post**

- 16) The contractor shall have to visit the site to comprehend the scope of work. The same will be arranged by the undersigned. The site can be visited between **13/06/2018 to 14/06/2018** between **10.00 hrs to 14.00 hrs.** on working days. However, prior intimation (e-mail: ptpophal@barc.gov.in, Tel no: 022-25594908) of at least three working days is necessary.

17) The quotations submitted without site visit will not be considered.

CONFIDENTIALITY CLAUSE

Confidentiality:

No party shall disclose any information to any third party concerning the matter under this contract generally. In particular, any information identified as "proprietary" in nature by disclosing party shall be kept strictly confidential by the receiving party and shall not be disclose to any third party without the prior written consent of the original disclosing party.

This clause shall apply to the sub-contractors, consultants, advisors or the employers engaged by a party with equal force.

"Restricted information" categories under section 18 of Atomic Energy Act 1962 and "official secrets" under section 5 of the official secrets Act 1923.

Any contravention of the above mentioned provisions by any contractor, sub-contractor, consultants, advisors or the employees of the contractor will invite penal consequences under the aforesaid legislation.

Prohibition against use of BARCs name without permission for publicity purposes.

The contractor or sub-contractor, consultant, advisor or the employees engaged by the contractor shall not use BARCs name for any publicity purposes through any public media like press, radio, T.V. or internet without the prior written approval of BARC.

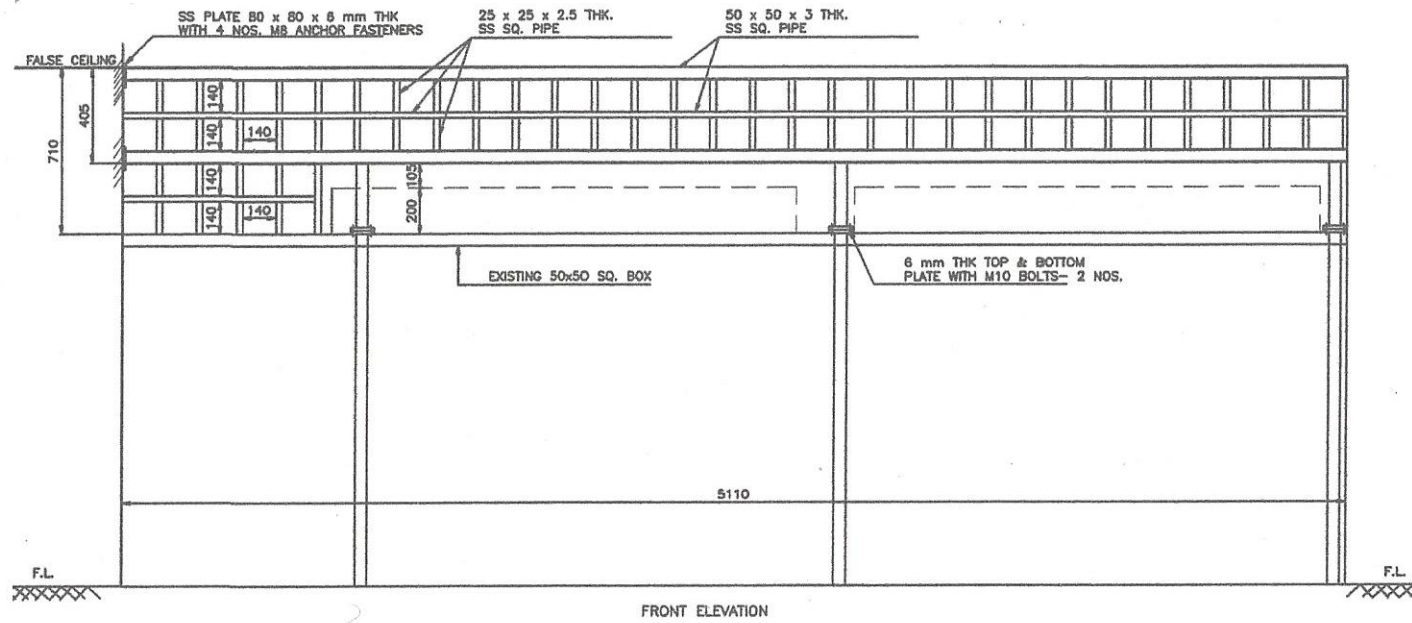
The above mentioned confidentiality clauses, may please be invariably incorporated in future contracts.
