Tender Enquiry for minor fabrication work

Sealed quotations are invited on behalf of President of India for the work as per following technical specifications.

Technical Specifications-Annexure-1

A. Scope of work:

- 1.1 Supply, fabrication and installation of 1 no. over head shed between MBS & Blower room, CEL-III made out of M S Angle, I Channel, GI Profile Sheets and civil work as per requirement.
Area of 600 ft² to be covered under shed.
- 1.2 100×50 M S Chanel of 6 mm thick-60 mtrs.
- 1.3 75×75×6 mm M S angle-60 mtrs.
- 1.4 50×50 M S Angle of 6 mm thick-60 mtrs.
- 1.5 0.7 mm thick blue color G I Profile sheets-30 nos.
- 1.6 J- Hooks to be used for fixing G I Sheets with frame.
- 1.7 Anchor fastener to be used for fixing vertical columns.
- 1.8 Half section PVC pipes to be used to drain out rain water from top of shed.
- 1.9 2 coats of red oxide and 2 coats of best quality paint to be applied on metal structure.
- 1.10 200mm×200 mm ×20 mm base plate to be used for all vertical columns.
- 2.1 Dismantling of metallic duct in MBS, CEL-III: 48 mtrs. (Apx.) Of size 500×500 mm. and 25 Mtrs. of size 250×250 mm. including fittings.

B. NOTES:

1. WORKMANSHIP AND FINISH SHALL BE EQUAL TO THE BEST IN MODERN SHOP PRACTICE AND SHALL BE IN ACORDANCE WITH THE REGULAROTY REQUIREMENTS.
2. ALL CUTTING AND SHEARING SHALL BE NEATLY DONE AND SURFACES EXPOSED TO VIEW SHALL HAVE A NEAR AND WORKMANLIKE FINISH. SHARP EDGE SHALL BE ROUNDED TO 1 mm RADIUS.
3. STRUCTURAL ELEMENTS SHALL BE FABRICATED IN ACCORDANCE WITH THE TOLERANCES OF IS 7215.
4. MATERIAL AS SPECIFIED.

C. General notes:

1. All supply from the fabricator shall be guaranteed for a period of 12 months from the date of supply.
2. The work carried out by fabricator shall be subjected to inspection by the user before acceptance.
3. Any delay which is attributable to the fabricator is liable for penalty @ 0.5% per week (max.5%) to be imposed on fabricator.
4. In case any extension to be granted to the contractor, party's request for extension may be called for before expiry of work order. The same may be justified by the division, whether extension granted is with or without levy of liquidated damages.

5. The contractor and his workers shall take all safety precautions as per standard procedure.
6. BARC shall not be held responsible for occurrence of any accident/personal damage during execution of work order and department will not be liable to pay any compensation.
7. Contractor and his workers shall have PVC from police department before taking up job defined in work order.
8. Quotations without PAN & GST number shall not be accepted.
9. The fabricator can visit the site if he desires so to evaluate the jobs listed in annexure-1 before submitting the quotation.

11. The quotations in sealed envelope super scribed with the title of work, reference no. and stipulated due date must be dispatched by Indian post (Speed Post) should reach to **Head, Chemical Technology Division, BARC, Trombay-85 by 12/06/2018 at 14:00 hrs.**

D. Terms of payments:

1. No advance payment shall be made.
2. Full payment shall be made after completion of entire work specified in work order.
3. Payment shall be made through cheque/ECS in favor of contractor by accounts officer BARC.
4. Contractor shall confirm the payment terms mentioned above.
5. Please mention PAN Number, GST no. in your quotation.
6. Income tax @ 2% shall be deducted from the bill.
7. The contractor shall have to submit in advance duly signed and stamped receipt along with the bills & necessary papers for the payment.
8. Necessary documents for release of payments shall be raised in the name of "Accounts Officer, BARC (Govt. of India) Trombay, Mumbai-400085

E. The following confidentiality clause shall be maintained


1. Confidentiality:

No party shall disclose any information to any third party concerning the matters under this contract generally. In particular, any information identified as "Proprietary" in nature by disclosing the party shall be kept strictly confidential by the receiving party and shall not be disclosed to any third party without the prior written consent of the original disclosing party. The clause shall apply to the sub-contractors, advisers, or the employees engaged by a party with equal force.

2. "Restricted information" categories under Section 18 of the Atomic Energy Act 1962 and "Official Secrets" under Section 5 of the Official Secrets Act ,1923 :- Any contravention of the above-mentioned provisions by any contractor, sub-contractor, consultant, adviser or the employees of the contractor will invite penal consequences under the aforesaid legislation.

3. Prohibition against use of BARC's name without permission for publicity purposes :-

The contractor or sub-contractor, consultant, adviser or the employees engaged by the contractor shall not use BARC's name for any publicity purpose through any public media like, Press, Radio, T.V. and Internet without the written approval of BARC.
