Annexure-1 Scope of work and technical specification

- 1.) Item to be repaired: 20 TR process water chiller installed at EBC, Kharghar, Navi Mumbai.
- **2.) Scope of work:** Job related to repairing of 20 TR process water chiller refrigeration line, compressor, pressure testing, refrigerant gas charging, servicing and testing.

3) Description of work:

- i) Repair, brazing, fitting & pressure testing of refrigerant gas pipe line up to pressure 350 psi.
- ii) Dismantling and replacement of compressor of 20 TR rating, Scroll type compressor.
- iii) Charging of refrigerant gas line with R407C gas up to pressure of 180 psi.
- iv) Servicing and cleaning of chiller components like condenser, evaporator, associated pipeline, valve, filters etc.
- v) Final testing of 20 TR water chiller at EBC, Kharghar.

4) Terms and conditions:

- i) The work will be carried out on working days, during regular working hours, that i.e. 9.30 to 18.00 hours only.
