On behalf of the President of India, **Head, Desalination Division, Chemical Engineering Group (ChEG)**, Bhabha Atomic Research Centre invites quotation in sealed envelope for the work given below.

The terms and conditions are given below:

1. Qualifying Criteria for Bidders:

- 1.1. Firms willing to bid for above mentioned job shall have been vetted by Security Section of BARC.
- 1.2. The firms shall have registered under IBR and past experience of IBR jobs.**
- 1.3. All the supervisors and workers should have valid Police Verification Certificate (PVC). The list of manpower available with firm shall be submitted along with their details of PVC with quotation.
- 1.4. **The past experience of the firm in similar nature of work related to boiler chimney fabrication/repair/installation is must & should be made available with work order copy and satisfactory completion certificate from the user.** Also the list of ongoing jobs inside BARC premises with expected completion period shall be provided.
2. **Interested bidders fulfilling the above criteria shall contact Mr. Shivayyanamath.S, Scientific Officer(G), on Phone No. 25594724/4639 for site visit & Detailed Tender Specifications-Annexure-1. Bidder shall visit the site for better understanding of the job. Vendor has to submit the request letter on company letter head along with valid documents satisfying the above criteria for obtaining the Annexure-1. Without collecting the Annexure-1, bidder will not be able to quote for the tender. Quotations by the bidders without following above procedure will be rejected & not considered for evaluation.**
3. The quotation envelope shall be superscripted with **description of the job** and the **Tender Ref. No.** mentioned above along with **Due Date**.
4. The complete quotation shall reach the following address on or before **09/12/2020** by **only Indian Postal Service**.

5. **Printed Letter Head:** Quotation should be printed on the letter head; computer generated quotation is not valid.
6. **Validity of the Offer:** Validity of the offer shall be **90 days** from date of opening of quotation.
7. **Offer of Firm:** Offer of those bidders, who do not submit their quotation as per the details given in the technical specification and incomplete quotations in any respect shall not be considered.
8. The department reserves right to extend the date of opening the quotations.
9. **Payment Terms:** Accounts Division, BARC, Mumbai-400085 shall make full and final payment only after submission of the satisfactory work completion certificate & site clearance certificate issued by the undersigned, bill, advanced stamped receipt, delivery challan and guarantee certificate. No advance is admissible.
10. **Income Tax Recovery Clause:** Income tax @ 2% will be deducted from the bill.
11. If any of the employee, consultant or partner of the bidder's company is an Ex-BARC employee, the same must be stated in the quotation clearly.
12. **GST/PAN Number:** Quotation must contain the GST and PAN number of the firm.
13. **Safety Rule:** The contractor shall follow all the safety procedures as per the normal industrial practice during the execution of the job at site. Any mishap occurring during the work due to unsafe workmanship shall be the contractor's liability.

14. **Guarantee**

The contractor shall guarantee for all supplied materials and good workman ship for a period of twelve (12) months from the date of completion of work, duly certified by our site engineer.

15. **Confidential Clauses:**

i. Confidentiality: No party shall disclose any information to any third party concerning matters under this contract generally, in particular, any information identified as "Proprietary" in nature by the disclosing party shall be kept strictly confidential by the receiving party shall not be disclosed to any third party without the prior written consent of the original disclosing party. This clause shall apply to the sub-contractors, consultants, advisors, or the employees engaged by a party with equal force.


ii. "Restricted information" categories under Section 18 of the Atomic Energy Act, 1962 and "Official secrets" under section 5 of the of the Official Secret Act, 1923: Any contravention of the above mentioned provisions by any contractor, sub- contractor, consultant, advisor or the employee of a contractor will invite Penal consequences under the aforesaid legislation.

iii. Prohibition against use of BARC's name without permission for any publicity purpose: The contractor or sub-contractor, consultant, advisor or the employees engaged by the contractor shall not use BARC's name for any publicity purpose through any media like press, TV or internet, without the prior written approval of BARC.

16. **Safety & Security Rules:**

- a) The contractor shall follow all the safety procedures as per the normal industrial practice during the execution of the job at site. Any mishap occurring during the work due to unsafe workmanship shall be the contractor's liabilities. The contractor has to sign "Industrial Safety Undertaking" before starting the job at BARC premises.
- b) Police verification certificates are required for supervisors and laborers deployed at the site.
- c) Security rules and transport rules at BARC, Trombay, premises shall be strictly followed.
- d) Laborers below 18 years of age shall be not allowed to work at site.
