1. The cost quoted should include Spares and labour charges and any transportation, if required, to and from our premises to your service centre.
2. In case of shifting to service station, the repair work is subjected to inspection by our departmental representative and the bidder shall provide necessary infrastructure to carry out the inspection.
3. The bidder should provide, **PAN & GST** registration numbers clearly along with his quotation in his letter head.
4. Any tax applicable should be mentioned separately.
5. The detail scope of work and the equipments covered are mentioned in the annexure.



Terms and conditions:

Comprehensive AMC would be, **for a period of 2 year**, from the date on which the work order is signed. However, the contract may be extended for a further period of one year on a mutually acceptable terms and conditions

1. All components of UPS including Magnetics (other than batteries), are to be covered under the comprehensive AMC.
2. During the period of AMC, you are required to provide four preventive maintenance services on quarterly basis and breakdown services as and when required.
3. You are required to provide the contact numbers & Email IDs of the service personal to be contacted and also contact number of at least two level immediate superiors to whom the complaints can be escalated in case of service related complaints.
4. In case of breakdown your service personal should be deputed to attend the call within 24 hrs from the time of booking the call. Your engineers should attend the breakdown call with required spares and complete the job immediately.
5. In case of defaulting to complete/rectify the complaint within 24 Hours, a penalty of Rs.500/ per hour is liable to be levied. Any extension of time due to technical reasons shall be permitted only on prior permission from officer-in-charge.
6. In case of any major breakdown in any component under contract period, you have to ensure continuous operation of our systems *by providing stand by units*.
7. The rates quoted are to be inclusive of all spares and service charges.
8. Payment would be made on half yearly basis on the based on your service reports duly signed by our engineers against your bill and advance stamped receipt.
9. No advance payment can be made against the work order.
10. During the period of service contract the contractor shall hold his rates firm and shall not revise his rates due to any reason.
