1. **Job description & scope of work:** Fabrication and supply of trapezoidal peripheral seal (VITON/Neoprene Rubber) for manually operated 80 NB bi-directional knife edge gate valve.
2. **Quantity:** 150 no
3. **Free issue material (FIM):** Not applicable
4. **Charges:** Basic cost per unit basis and taxes extra.
5. **Delivery:** Delivery at RUMP/UED, south site, BARC, Mumbai-85 within 60 days
6. **Guarantee:** You shall give guarantee against any manufacturing defect and trouble free performance for a period of one year from the date of the receipt of the material.
7. **Deduction of Income taxes:** Income Tax @ 2% and other surcharges as applicable will be deducted from your bill.
8. **Payment:** 100% after satisfactory completion of work and submission of the following documents.
 - a. Delivery Challan
 - b. Original Invoice with GST
 - c. Advance stamped receipt
 - d. Guarantee certificate
 - e. ECS mandate form
 - f. PAN/GST Number etc.
 - g. GST undertaking as per Annexure - II

- h. This is to clarify that that BARC is the final consumer of the goods/services procured against this work order and does not intend to make any outward supply. BARC will not avail the benefits of Input Tax Credit and hence, the goods can be supplied without quoting the GSTIN of BARC, Mumbai on the invoice. The invoices taxed under GST, as per rates applicable under the GST Schedule of Rates, shall be admitted for payment**

Please note that any delay, which is attributable to the party, is liable to penalty @ 0.5% per week (max. 5.0%) to be imposed on the contractor.

9. TERMS AND CONDITIONS:

- I. Confidentiality:** No party shall disclose any information to any third party concerning the matters under this contract generally. In particular, any information identified as "Propriety" in nature by the disclosing party shall be kept strictly confidential by the receiving party and shall not be disclosed to any third party without the prior written consent of the original disclosing party.
