Quotation is hereby invited for and on behalf of President of India for following works to be completed in six months at AFD/BARC

- 1) Assembly of Aluminium rod bundles, 150 bundles, @ 25 bundles/ month.
- 2) Aluminium tube ID cleaning and their swaging-1500 nos. on site, @ 250 tubes/pm.
- 3) Aluminium tube weld joint filing, 1200 nos. on site, @ 200 tube welds/pm.
- 4) Aluminium rod sizing, 1500 nos., @ 250 rods/month
- 5) Filing of Aluminium piece -1200 nos. on site, @ 200/pm. .

Terms and Conditions:

1. All the works shall be carried out at site.
2. Necessary equipments such as surface plate, assembly fixture, filing fixture hacksaw, files, swaging machine etc will be provided by us.
3. Personal protective gears such as boiler suit, hand gloves will be provided by us.
4. At least 2 skilled (fitter), 2 semiskilled and 2 unskilled persons shall be available on the site to carry out the work on regular basis except Saturday Sunday and holidays for a period of six Months from the date of order.
5. All the safety precautions must be taken while working on site. Any loss or damage to the property / machines will be recovered from you.
6. You should arrange for the Police verification certificate for your personnel. No person without PVC will be allowed to enter inside BARC.
7. Necessary safety precaution must be taken while working on site. BARC will not be responsible for any injury or accident taking place on site.
8. The work should be completed as specified. Any delay will be liable for penalty @ 0.5% per week.
9. Personnel working at site should carry out cleaning of site and it's surrounding at regular intervals and maintain safe and hygienic working environment.
10. Visit of the vendor or his representative to AFD/BARC, prior to submitting the quotation is must, in order to understand the work and site condition. Vendor may visit to BARC, for inspecting the site with prior intimation of at least 3 days to R K Srivastava, AFD, BARC, Mumbai-400085, Ph-022-25594968, email rohiths@barc.gov.in. The visit will be approved only after verification of credentials of the visitor. The visit may be carried between on 30/10/2018 - 11.00 am to 5.00 pm. No visitor will be entertained before and after 30/10/2018.
11. The visitor must have genuine identity proof and valid Police verification certificate.
12. Quotation received from any vendor, without visit to AFD/BARC, will be rejected.
13. The vendor shall clearly indicate following in the quotation.
 - Net price

- Taxes & duties applicable , if any
 - GST Registration No.
14. Quotation must be typed on the printed letter head.
 15. Quotation must be sent by Speed post / Registered post only.
 16. Declaration stating whether you are ex-employee of BARC/DAE and whether you have any employee on your roll, who is an ex-employee of BARC/DAE.
 17. Sealed envelope containing quotation shall be super-scribed as “Quotation for miscellaneous works related to fabrication of Aluminium rods on site ” due on **8/11/2018**.
 18. Payment will be made after completion of work and submission of bill copy/invoice.
 19. The taxes as applicable will be deducted from your bill.
