The terms and conditions are given below:

1. Qualifying criteria for bidders:

- 1.1 Firms willing to bid for above mentioned job shall have been vetted by Security Section of BARC.
- 1.2 All the supervisors and workers should have valid Police Verification Certificate (PVC). The list of manpower available with firm shall be submitted along with their details of PVC.
- 1.3 The past experience of the firm in similar nature in BARC/DAE shall be made available with Work Order copy and satisfactory completion certificate from the user. Also the list of ongoing jobs inside BARC premises with expected completion period shall be provided.
- 1.4 Interested bidders shall contact the undersigned on Phone No. 2559 3344 (Ext. No. 23344) or Email - guptar@barc.gov.in with above mentioned details for getting the Detailed Tender Specifications. **It is compulsory to collect tender documents and quote price as per technical specifications (Annexure-C). Quotations send without collecting tender documents will not be accepted and will not be consider for opening.**

2. The quotation envelope shall be superscripted with **Description of the job and the Tender Ref. No.** as mentioned above.
3. The complete quotation shall reach the following address on or before 25/02/2019 05:00 pm by **Registered Post/ Speed post only**. The quotations shall be opened on 26/02/2019 in presence of undersigned and the members of designated committee of AMMD, BARC at Hall-5, Trombay, BARC or any other suitable place within the premises between 1430 to 1630 Hrs.

4. **Printed Letter Head:** Quotation should be printed on the letter head, computer generated quotation is not valid.
5. **Validity of the Offer:** Validity of the offer shall be 90 days from date of opening of quotation.
6. The time allowed for the completion of this work in all respect will be 30 working days only, from the date of issue of work order.
7. Since goods to be supplied against this tender are meant for scientific research purpose of a research institute under Department of Atomic Energy, no excise duty is payable for the goods covered for this work order. The undersigned will make available the excise duty exemption certificate to avail of the excise duty exemption, well before the delivery date. It shall however be the responsibility of the successful bidder also to ensure that they dispatch the goods only after getting an excise duty exemption certificate from the undersigned.
8. Accounts Division, BARC, Mumbai-400085, shall make full and final payment only after submission of the satisfactory work completion certificate, bill, guarantee certificate, delivery challan , advanced stamped receipt and proof of PAN. No advance/part payment or against delivery is admissible.
9. Income Tax at the rate of 2% will be deducted from the bill.
10. Any delay, which is attributable to the contractor, is liable for penalty @ ½% per week (max 5%) and the same shall be imposed on the contractor.
11. Incomplete quotations, in any respect, shall not be considered. PAN No. and Tax Registration No. should be mentioned in the quotation. The quotation shall be submitted in vendor's letter-head and duly signed & stamped by the authorized person.
12. In the quotation the vendor will also declare clearly as to whether the bidder has any relation in BARC or the bidder himself is an ex-employee of BARC or the bidder has an ex-employee of DAE on his pay rolls.
13. Along with quotation, vendor may also submit Xerox copy of contractor/welder licenses/certificate issued by any competent authority.
14. The vendor shall be liable for any damage to the purchaser or any third party arising out of the patent or latent defect in the goods supplied by him or sub-standard services rendered by him.
15. The Department reserves right to extend the date of opening the quotations.
16. Department shall communicated to the successful bidder only.
17. **The contractor shall also abide with the following confidentiality clauses :**
 - (a) **Confidentiality:** No vendor shall disclose any information to any third vendor concerning the matters under this contract generally. All the drawings if supplied along with or in relation with this tender must be returned. The clauses shall apply to the sub-contractors, consultants, advisers or the employees engaged by a vendor with equal force.
 - (b) **"Restricted Information" categories under section 18 of the Atomic Energy Act, 1962 and "Official Secrets" under section 5 of the Official Secrets Act, 1923:** Any contravention of the above mentioned provisions by any contractor, sub-contractor, consultant, adviser or the employees if a contractor will invite penal consequences under the aforesaid legislation.
 - (c) **Prohibition against use of BARC's name with permission for publicity purposes:** The contractor or sub-contractor, consultant, adviser or the employees engaged by the contractor shall not use BARC's name for any publicity purpose through any public media like Press, Radio, T.V. or Internet without the prior approval of BARC.
