1. Interested bidders should submit an application for obtaining the tender with their company profile and details of similar type of work executed in BARC in the recent past and the jobs currently undertaken.
2. Bidders may contact the undersigned (**Tel: 25590975**) on any working day for briefing, site evaluation and issue of tender.
3. All bidders should provide documentary evidences of similar type of work executed in BARC or any other DAE units.
4. Copies of PVC for their employees also should be submitted for verifications.
5. The tender will be issued free of cost to shortlisted bidders only after scrutinizing their credentials as submitted above and not be sent by post or courier.
6. The tender will be issued from 10/11/2017 to 20/11/2017 on all working days.
7. Sealed quotations will be accepted at our office via **speed post** through India Post only on or before 20/11/2017 and the quotations will be opened on next day. Hand delivered quotations will be NOT be accepted.
8. The quotations will be opened by an authorized committee in Chemical technology Group/BARC or at Accounts Division and no bidders are allowed to witness it due security reasons.

GENERAL TERMS & CONDITIONS:

1. Details of the job & technical specification are available in the tender documents.
2. Since work should be executed immediately, the bidders who have existing work force with police verification certificate (PVC) issued by Police department only need to participate in this tender. The PVC is a mandatory requirement for entry & work in BARC premises.
3. The firm should have preferably vetted for security clearance by security department of BARC.
4. Copy of the PVC for the employees of the bidder shall be enclosed along with the offer. Since this job involves site work at BARC premises; any offer without copies of the valid PVC will not be accepted.
5. All materials required to execute this work shall be procured and supplied by the contractor.
6. Time period to complete this work will be 1 month from the date of issue of work order. Time is the essence of this tender and hence no extension will be permitted.
7. The contractor shall give guarantee in writing for materials used and workmanship for a period of one year from the date of completion and commissioning of the work.
8. No advance payment will be made for execution of this work. 100% payment will be released after completion and satisfactory commissioning of the work and certification by our Engineer.
9. The contractor and their workmen shall take all safety precautions as per standard procedure while executing the job.
10. All tools & safety gears required for executing this work should be provided by the contractor.
11. This department will not be responsible for any accident happens while doing any job and no compensation will be payable by this department for any such incidents.
12. The successful bidder shall give guarantee in writing for materials used and workmanship for a period of one year from the date of completion and commissioning of the work.
13. **Liquidated damages:** Any delay in execution of the work, which is attributable to the contractor, is liable for penalty @ ½ % per week (max. 5%) will be imposed on successful contractor.
14. **Termination clause:** If the work is not executed to our satisfaction or delayed beyond reasonable time, the purchaser shall have the option to terminate the work order as is where is condition at any time during the currency of contract and the work shall be got executed through other agencies at your cost.

15. **Confidential close:**

- a) No party shall disclose any information to any third party concerning the matters under this contract generally. In particular, any information identified as "proprietary" in nature by disclosing party shall be kept strictly confidential by the receiving party without the prior written consent of the original disclosing party.
- b) This clause shall apply to the sub contractors, contractors, advisors, or the employees engaged by the party with equal force.
- c) **"Restricted Information" categories under section 18 of the Atomic Energy Act, 1962 and "official secrets" under section 5 of the Official Secret Act 1923.**
- d) Any contravention of the above mentioned provisions by any contractor, sub contractor, consultants, advisors or the employees of the contractor will invite penal consequences under the aforesaid legislation.
