Sealed Tenders are invited for & on behalf of the President of India by Head, Radiological Physics and Advisory Division, Bhabha Atomic Research Centre, CT&CRS Building, Anushaktinagar, Mumbai-400094 from reputed contractor/Service Provider who are fulfilling eligibility criteria for supply, installation and fixing of "CT&CRS" SS(304L) letters (two set) One set to be fixed horizontally and other set vertically on the top of the CTCRS building and also painting "CT&CRS name on the right side of the wall of the CTCRS building, Anushaktinagar, Mumbai as per attached annexure-I & II.

Scope of work:

1. Bidder shall quote for this fabrication job with materials and all the other items and conditions as per the attached annexure –I & II.
2. Taxes, GST, other charges, if any, shall be quoted separately.
3. The quotation must reach **Head, RP&AD by 20.11.2017 before 16.30 hrs** and must be sent in a sealed envelop superscribed with the reference number & the due date given above by INDIAN POST only.

8. Offer received after the due date shall not be considered.
9. Quotations should be preferably neatly typed and corrections are not acceptable.
10. Quotation received in computer-generated form shall not be acceptable. Quotation must be submitted in printed letterhead, mentioning clearly GST registration no. and PAN No.

Annexure-II

TERMS AND CONDITIONS

1.0. Free issue of material:

Free issue material will not be issued by the purchaser. The scrap material shall be disposed off by the contractor.

2.0. Quality surveillance, inspection and inspection report

2.1 All works covered under specification shall be subject to quality surveillance by the purchaser or his authorized representative for which purpose the fabricator shall allow access at all reasonable times during fabrication to:

2.1.1. The premises in which the work is being carried out

2.1.2. The drawings and/or tools involved

2.1.3. Gauges, Instruments. Etc., being used for the work

2.2 The fabricator shall submit three copies of inspection reports (Material Test Certificate) from Govt. approved laboratory to the purchaser for approval.

2.3 Components found unsatisfactory in respect of workmanship or material quality shall be removed by fabricator and replaced by components, which are approved as per specifications.

2.4 The finished components shall not be dispatched prior to approval by our engineer at bidder's works

3.0. Delivery:

3.1. The fabricator shall deliver the finished material after approval of our APO within **30 days** from the date the firm purchase order is issued.

3.2 Delay in completion of the job, for unavoidable reasons, shall be got approved by the indenting officer in advance prior to actual delivery of the finished product.

3.3 Any delay which is attributed to the contractor is liable for penalty @ 0.5% per week (max 5 %) to be imposed on the contractor.

4.0. Warranty/Guarantee

4.1. The fabricator shall submit warranty/Guarantee not sub-contract any or all the work without written consent from the purchaser. The fabricator shall be responsible to the purchaser for all work of the sub-contractor of the fabricator if allowed by the purchaser.

4.2 Fabricator should submit one year warranty/Guarantee certificate.

5.0. Tax: Income Tax @ 2 % will be deducted from your bill.

6.0. Payment

Payment shall be made only on satisfactory completion of work. Payment against delivery cannot be made. The fabricator should necessarily furnish their PAN no along with the bill. You have to submit the bill in triplicate along with advance stamped receipt to the Division in favour of Accounts Office, BARC. Payment will be made only through ECS. Name & address of the party's Bank, Account Number, IFS code, MICR No. which appears on cheque leaf, PAN no., GST registration no. of the party should also be quoted on the bill.

7.0. Confidentiality

No party shall disclose any information to any third party concerning under this contract generally. In particular, any information identified as "proprietary" in nature by the disclosing party shall kept strictly confidential by the receiving party and shall not be disclosed to any third party without prior written consent of the original disclosing party.

This clause shall apply to the sub-contractors, consultants, advisers or the employees engaged by a party with equal force.

"Restricted information" categorized under section 18 of the Atomic Energy Act, 1962 and "Official Secrets" under section 5 of the Official Secrets Act, 1923.

Any contravention of the above-mentioned provisions by any contractor, sub-contractor, consultant, adviser or the employees of a contractor will invite penal consequences under the aforesaid legislation

Prohibition against use of BARC's name without permission for publicity purpose:

The contractor or sub-contractor, consultant, adviser or the employees engaged by the contractor shall not use BARC's name for any publicity purpose through any public media like press, radio, T.V. or Internet without the prior written approval of BARC .
