**1.0 Scope of Work:**

The work involves the following activities:

**2.0 Prices:**

- (i) The party should quote the total price for given quantity of work.
- (ii) Basic price and taxes shall be quoted separately. Any other levies or duties if required and applicable shall be mentioned in the offer.

**3.0 Work completion period:**

- (i) Work should commence within one month after placement of work order.

**4.0 Free issue material:**

No free issue material will be provided.

**5.0 Penalty:**

Any delay which is attributable to the contractor is liable for penalty @ ½ % per week (max 5 %) to be imposed on the contractor.

**6.0 Payment:**

No advance/part payment will be made. Full payment will be made by ECS/RTGS within 3 to 4 weeks after satisfactory completion of works and submission of bills with advance stamped receipt, workmanship certificate and ECS/RTGS payment option form.

**7.0 Deduction of taxes and surcharges:**

Income tax @ 2% (or as applicable) plus education cess will be deducted from the bill.

**8.0 Confidentiality Clause:****Confidentiality:**

No party shall disclose any information to any third party concerning the matter under this contract.

**Restricted information**

Categories under section 18 of the Atomic Energy Act, 1962 and "official secrets" under section 5 of Official Secret Act, 1923 – Any contravention of the above-mentioned provisions by any contractor, sub-contractor, consultant, advisor or the employee of a contractor will invite penal consequences under the aforesaid legislation.
