Sealed quotations are invited on behalf of President of India by Head, Accelerator & Pulse Power Division in sealed envelopes for Execution of various jobs related to ICS, like material shifting, fabrication, assisting in testing and up keeping of various equipments and area of ICS Gamma field site and rearrangement of test set up materials located at Hall-9 as per instruction of our engineers for 12 calendar months. As per Annex-1.

- 1) Scope of work: As per "Technical Specifications Annex -1 for Execution of various jobs related to ICS Gamma field and Hall-9" enclosed.
- 2) Work completion and Validity period: 12 calendar months from the date of acceptance of work order. Price should be firm throughout the currency of contract. The rates quoted shall remain valid for 90 days.
- 3) Bidder should quote lump sum cost for work including all taxes and duties. However, any other taxes and charges, if any, shall be indicated separately.
- 4) Payment:
 - a) Payment will be made as per rules, after the completion of the work to purchaser's satisfaction against submission of original bill in triplicate and advance stamped receipt. Advance/Part payment or against delivery cannot be made.
 - b) 100% payment shall be made by cheque / ECS (Please furnish details) after completion of job subjected to the satisfaction of purchaser.
 - Deduction of Taxes: Income tax @2% and Educational cess as applicable will be deducted from the bill.
 - d) A penalty @ 0.5% per week (max. 5%) shall be levied for delay in completion of work. Bernel

- e) Payment shall be made only on satisfactory completion of work and on production of bill, advance stamped receipt.
- f) Since the goods are to be supplied against the work order meant for research purpose of a research organization under DAE, the necessary GST will be exempted to the party.

5) <u>Confidentiality clause:</u>

a) Confidentially:

Party shall not disclose any information to any third party concerning the matters under this contract generally. In particular, any information identified as "Property" in nature by disclosing party shall be kept strictly confidential by receiving party and shall not be disclosed to any third party without the prior consent of the original disclosing party.

This clause shall apply to sub-contractors, consultants, advisors or the employees engaged by the party with equal force.

b) Restricted information:

Categories under section 18 of the Atomic Energy Act, 1962 and "Official Secrets" under section 5 of the official Secret Act, 1923 - Any contravention of the above-mentioned provisions by any contractor, sub- contractor, consultant, adviser or the employees of a contractor will invite penal consequences under the aforesaid legislation.

c) Prohibition against use of BARC'S name without permission for publicity purpose: The contractor or sub-contractor, consultant, adviser or the employees engaged by the contractor shall not use BARC'S name for any publicity purpose through any public media like press, Radio, T.V. or Internet without the prior written approval of BARC.

6) General instruction to bidder:

- a) Supplier should have GST registration. He should clearly write GST No. and PAN No. in his quotation, otherwise the quotation will not be considered.
- b) Sealed envelope containing quotation must reach the following address on or before 06/04/2022 by 17.00 hrs.

SCOPE OF WORK:

A. ICS Facility

- Cleaning of site cabins, interior of gantry scanner, Motorized gate railing platform, Service building rooms.
