Instruction to the party:

- For further details of the work and site visit, party may contact to undersigned at below given contact no. along with company profile and work experience in same field on their letter head.
- The party should write in words as well as figures, the consolidated cost plus
 applicable GST quoted by him. All correction must be attested by the dated initials of
 the party.
- The Party may note that in case the work is awarded to him, he has to produce the police verification certificate for the employees to be deputed for the work inside the BARC/BRIT, Complex, Navi Mumbai.

- Party should have at least five to six year experience of providing annual maintenance contract of air handling unit, package unit and split air conditioners.
- Income-Tax and surcharge on income- tax as applicable shall be deducted from the bill. The payment for the work done shall be paid by our Account Division only on satisfactory completion of the work on every quarterly (three months) basis.
- The party must provide PAN No. and GST no. of the firm/company along with offer.
- Comprehensive maintenance contract is valid for two year. The same shall be reckoned from the date of issue of work order.
- The acceptance of the tender rests upon the undersigned with right to reject the offer without assigning any reason.

Scope work under Comprehensive AMC

Air handling unit is once through Dx -type 52 TR and 4500cfm. AHU is consist of three nos. of scroll hermetic compressor each 13 TR, two nos. of shell & tube water cooled condensers, twelve row deep cooling coil, FRP counter -forced flow cooling tower and consist PRE+HEPA air filters. The system has one stand by unit of same configuration.

AHU shall be covered under the comprehensive AMC along with following work as under.

Monthly

- Cleaning of Fresh air line HDPE filters.
- Cleaning of cooling tower sump.
- · Checking of refrigerant leakages.
- · Checking of Safety control system.
- Checking of all electrical connection and ensure healthyness.

Half yearly

- Condenser cleaning with chemicals and brushing.
- 12 Row Deep dx- type cooling coil cleaning by water jet with approved cleaning chemical.
- Cleaning of cooling tower nozzles and packed PVC fills.
- Greasing of water pumps bearings.
- Cleaning of water pump strainer.
- Top up of refrigerant, if system is lack of refrigerant.

Breakdown/Repair Works

- Any breakdown in the system including compressors, microprocessors, AHU control system, electrical connectors, and loss of refrigerant shall be attended by contractor without any extra charges.
- Supplied items by the vendor shall have warrantee/guarantee of one year.
- Party has to strictly maintain system free from refrigerant leakages.
- System shall be kept free from vibration and abnormal noise.
- Any brazing/welding joint should be strong, smooth and free from leakages.
- Any complaints regarding breakdown and repairs shall be attended within 24 hrs.

Note: Party should quote consolidated cost plus applicable GST for all comprehensive AMC work as described above including spares for two year. Bifurcated offer (separate cost) of the work shall be treated invalid. Technicians should have ITI/ NCVT certificate of A.C. Mechanic trade and two year experience in relevant field. All required tools and spares shall be arranged by vendor. Vendors shall be provided only electrical and water supply free of charge from the department at the site.

Terms and conditions:

- Materials: No free material will be provided to the party. All the materials i) required for the work will have to be provided by the party. All the materials should be of standard specifications available in the market and approved by the officer in- charge. The materials brought to the site should be got approved from the undersigned before use for the work.
- Tools: All the tools required for the work shall be arranged by party. Free ii) electricity and water supply will be provided for the work.
- Safety: All the personnel of the contractor should take care of safety and follow iii the industrial safety regulation while working at site. Specific personnel protective equipment (PPE) required for the job will be provided by BARC as and when required. Any mishap occurring on the job due to unsafe work practice shall be vendor's liability.
- Security: Police Verification Certificates (PVC) are required for supervisor and all iv) workers employed by the contractor inside the BARC. Security instructions on entry of workers, working time etc. are to be followed strictly.
- Work completion: The time allowed for completion of the job is two year. The v) same shall be reckoned from the date of issue of work-order. Party should engage skilled and semi-skilled workers for the work with adequate supervisory staff.
- Payment: No advance or part payment will be made. The payment shall be vi) made quarterly (four months) only on satisfactory completion of the work. Vendor shall submit of tax invoice, advance stamped receipt, GST under taking, acknowledgment copy of last two year ITR and guarantee/warranty certificate for material quality and workmanship on quarterly (three months) basis. contract shall be valid for two year. Income Tax @2% or as applicable at the time of billing will be deducted from your bill.
- Penalty for delay: Any delay which is attributable to the contractor is liable for vii) penalty @1/2% per week of the total value of the work-order subject to a ceiling of 10% of the total value.
- The contractor shall be wholly responsible for any labour related disputes and any viii) injury to contractor's worker during execution of the job.
- Head, Powder Metallurgy Division, BARC, reserve the right to cancel the tender or ix) work order without assigning a reason to the party.
