Terms & Condition

Scope of work:

Thorough cleaning, lubrication, testing, re-adjusting, replacement of parts needed for proper operation. Repair of defects during the currency of the contract. Upkeep of the equipment in upto date condition during the currency of the contract.

Replacement of spare parts: The cost of the spare part replaced during the currency of the contract will be paid extra at actuals. However, the parts may be replaced with approval of user department regarding the reasonableness of cost and necessity of replacement. The price list for the spares shall be enclosed separately with the quotation for the AMC.

Periodicity of Routine visit: During the currency of the contract, 03 services should be carried out (i.e. 03 services every year, one service every 04 months) & all breakdown calls.

Period of contract: This contract shall remain in force for a period of 01 (one) year commencing from date of placement of work order

Service Charges: Service Charges accepted shall be firm during the currency of the Contract.

While the contract is intended to be valid for a period of one year, this Division reserves the right to terminate this contract by giving a notice of one month and without any financial obligation on the part of this Division. In the event of cancellation of the contract for a reason or the other the payment for service carried out will be paid on pro-rata basis. Proportionate amount shall be deducted from AMC charges for non-servicing period.

Emergency Call: Emergency/Breakdown call from the user department should be attended immediately but not later than 24 hours at no extra cost.


