Performance Guarantee of 3% can also be accepted in the form of Demand Draft or Fixed Deposit Receipt or Bank Guarantee of any Scheduled Bank/Nationalised Bank. The estimated cost indicated is only approximate and the contractor shall work out the rates on the actual

The tenderer shall produce the solvency certificate equivalent to 40% (Rs.7,00,000-00) of the cost put to tender for financial soundness at the time of submission of tender document.

Similar works means having experience in any Civil/House Keeping (Cosmetic Maintenance) Works. The value of executed work shall be brought to the current costing level by enhancing the actual value of work at simple rate of 7% P.A. calculated from the date of completion to the last date of receipt of application for tender.
