Sub: Invitation of quotation for carrying out Segregation and Shifting of materials, equipments for major projects under manufacture at CDM.

You are requested to send your most competitive quotation for the job as per following description.

1.0 Scope of Work:

The work involves the following activities:

S. No	Description of work	Quantity
(i)	Collection & segregation of different scrap materials from machine shops, storing them separately and further disposal to the designated sites within BARC premises.	24000 Kg
(ii)	Shifting and arranging heavy objects, equipments and raw materials etc. at different location of CDM.	30000 Kg
(iii)	Removal of chips from machines and general cleaning of workshop area of CDM.	1500 m ²

2.0 Prices:

- (i) The party should quote the total price for given quantity of work.
- (ii) Basic price and taxes shall be quoted separately. Any other levies or duties if required and applicable shall be mentioned in the offer.

3.0 Work completion period:

- (i) The work will be based on the site requirement. Two number of workers to be supplied every day after the placement of work order. Time required to complete the above work will be minimum one year i.e. minimum 520 mandays from the commencement of work.
- (ii) Work should commence within one month after placement purchase order.

4.0 Facility would be made available by BARC:

- (i) Fork lift/ crane for movement of heavy items wherever possible.
- (ii) Free electricity and water supply, if required and wherever possible.

5.0 Free issue material:

No free issue material will be provided.

6.0 Penalty:

Any delay which is attributable to the contractor is liable for penalty @ $\frac{1}{2}$ % per week (max 5 %) to be imposed on the contractor.

7.0 Payment:

No advance/part payment will be made. Full payment will be made by ECS/RTGS within 3 to 4 weeks after satisfactory completion of works and submission of bills with advance stamped receipt, workmanship certificate and ECS/RTGS payment option form.

8.0 Deduction of taxes and surcharges:

Income tax @ 2% (or as applicable) plus education cess will be deducted from the bill.

9.0 Confidentiality Clause:

Confidentiality:

No party shall disclose any information to any third party concerning the matter under this contract.

Restricted information

Categories under section 18 of the Atomic Energy Act, 1962 and “official secrets” under section 5 of Official Secret Act, 1923 – Any contravention of the above mentioned provisions by any contractor, sub-contractor, consultant, advisor or the employee of a contractor will invite penal consequences under the aforesaid legislation.

Prohibition against use of BARC’s name without permission for publicity

The contractor or sub contractor, consultant, advisor or the employees engaged by the contractor shall not use BARC’s name for any publicity purpose through any public media like press, radio, TV or internet without the prior written approval of BARC.

10.0 General Instruction:

- (i) The Contractor shall follow all the security procedures for working in BARC. The contractor should arrange for the PVC of the persons working inside BARC and should be responsible to submit all the supporting documents for the preparation of entry pass.
- (ii) All the persons who work shall be physically & mentally fit and shall follow industrial & safety precautions and BARC shall not be responsible for any damage, injury, death etc. of any contractor's personnel under any circumstances.
- (iii) Sealed Quotation should be super scribed as **“Segregation and Shifting of material, equipment for major projects under manufacture at CDM”**, with tender number of this inquiry letter.
- (iv) The progress of work will be reviewed periodically. If the work is not carried out by the contractor satisfactorily and any deficiency is noticed, recovery towards the deficiency will be made from the contractor's bill and the decision of Competent Authority shall be final and binding on the contractor.
- (v) Competent Authority reserved the right to terminate the contract at any stage of execution of the contract, without assigning any reasons.

The sealed quotation delivered by Indian post should reach the undersigned before 1500 hrs. on 22nd May 2018 .
