Reference is invited to this Department's Endorsement No.GF-107 & 80-SCS/10068 dated 06.08.2018(Annex-1) and subsequent Note No.19/2/2019-SCS/3688 dated 20.03.2019 (Annex-2), on the captioned subject.

2. The matter has been examined in the Department in consultation with TC&TSC, BARC and it has been decided to implement the Ministry of Finance, Department of Expenditure O.M.No.4-21/2017-IC/E.III(A) dated 31.07.2018, read with subsequent clarification issued vide their O.M.No.4-21/2017-IC/E.IIIA dated 28.11.2019 (Annex-3), for Scientific & Technical; Administrative; Accounts and Auxiliary category of personnel of the Department of Atomic Energy.

3. The pay fixation may be done accordingly for all category of personnel in the Department of Atomic Energy in accordance with Ministry of Finance OM dated 31.07.2018 and OM dated 28.11.2019 referred to above. However, the payment towards arrears of pay for the promotions taken place from the year 2016 to the year 2019 may be kept on hold until further orders.




