#### Order of the First Appellate Authority (FAA):

In connection with of the appeal, it is intimated that, the CC alongwith interest worked out from 1982-83 to 2009-2010 is correct and based on information available in the file. Shri Chandran is advised to approach the Dy: Controller of Accounts(PF) and specify how the information given is incorrect. Regarding Point Nos.2 &3 of the appeal, it is mentioned here that, Shri Chandran was transferred from RMP, Mysore in April 2003 and PAO, RMP has transferred the PL amount of 134711- as on that date in June, 2003. Accordingly PF Ledger Card was made in 2003-04 in BARC and since then the Annual PF slip copies were provided to him vide this office letter dated 16.3.2011. From 2003-04 to 2007-08, the PF account was maintained under GPF and hence no CC. Ever since Shri Chandran was

reverted to CPF vide office Order dated 12.3.2008, the FE account was maintained i.e. from 2008-09 onwards with GC. But the CC shown in the FE card 2008-09 is incomplete without Opening Balance. CC-nas to be worked out by FE section right from the date of joining till 2009-10 with the help of Service Book details and the entire CC has been projected in a separate Working sheet provided to him on 16.3.2011. Since the GC is provided for all the years (i.e. from the date of joining) only in 2009-10, this cannot be shown along with Annual slip issued every year till 2009-10.

Ground of the Second Appeal:

Unsatisfactory reply was given by the PIO and Unsatisfactory order was passed by the FAA,

# Relevant Facts emerging during Hearing:

The PIO has given information as available on records to the Appellant. The appellant states that earlier he also been given one statement and now the statement given to him is different. The respondent states that the information available on the records has been provided to the Appellant. The appellant appears to have a grievance that earlier he had been given to understand that there was a larger amount in his PF account and the information provided to him in R11 shows the amount to be lower. For this the Appellant will have to approach an appropriate forum since the PIO states that the information has been provided as per available records.
