PIO replied on : 24.11.2023

Information sought and background of the case:

The Appellant filed an RTI application dated 25.10.2023 seeking information on following points:-

- 1) Copy of Beacon light case purchase receipt in department.
- 2) Copy of Beacon light material management system.
- 3) Copy of Beacon light permit from ministry of road transport and highways
- 4) Copy of Beacon light own purchase receipt (if purchased).
- 5) A copy of the permission obtained from our department to install the Beacon light on the vehicle number MH03 AN 0128.
- 6) Copy of departmental action taken if permission is not obtained.

The Chief Administrative Officer (A) & CPIO, Bhabha Atomic Research Centre (Mumbai) vide letter dated 24.11.2023 replied as under:-

“Point No. 1 to 5:- No such information is available.
Point No. 6:- Not applicable.”

Dissatisfied with the response received from the CPIO, the Appellant filed a First Appeal dated 25.11.2023. The FAA vide order dated 21.12.2023 upheld the reply of CPIO.

Aggrieved and dissatisfied, the Appellant approached the Commission with the instant Second Appeal.

The Submissions of both the parties were heard. Further, the written submission 27.1.2025 filed by the Respondent were considered.

Decision:
