Information sought and background of the case:

The Appellant filed an RTI application dated 23.11.2023 seeking information on following points:-

- 1) "copy of height of Deputy cheif security officer(A) (anushaktinagar) at the time of Assistant security officer physical exam.
- 2) A copy of the height prescribed by department to the Assistant security officer period 1992-2000.
- 3) Copy of anushaktinagar Deputy cheif security officer(A) mandatory induction training.
- 4) Copy of the year of commencement of physical exam for Assistant security officer.
- 5) Copy of the Assistant security officer recruitment criteria period 1992-2000.
- 6) Copy of anushaktinagar dcso((A) sop.
- 7) Copy of A.S.O TO S.O, S O TO DCSO, DCSO TO CSO promoted department criteria.

The Chief Administrative Officer (A) & CPIO, Bhabha Atomic Resarch Centre (Mumbai) vide letter dated 19.12.2023 replied as under:-

- 1. As informed by deemed PIO, DYCSO (A) posts does not exists in BARC
- 2. As informed by deemed PIO & as far as BARC, Mumbai is concerned, the information sought is not available in this Centre
- 3. As informed by deemed PIO, DYCSO (A) posts does not exists in BARC

4, 5 & 6. As informed by deemed PIO & as far as BARC, Mumbai is concerned, the information sought is not available in this Centre 7. It is informed that the recruitment rules for ASO (A), SO, DyCSO, CSO is available in public domain under the link https://dae.gov.in/reruitment-rules/."

Dissatisfied with the response received from the CPIO, the Appellant filed a First Appeal dated 23.12.2023. The FAA vide order dated 02.02.2024 upheld the reply of CPIO.

Aggrieved and dissatisfied, the Appellant approached the Commission with the instant Second Appeal.
