Instructions to the tenderer :

- The tenderer should write in words as well as figures, the rate(s) quoted by him. All corrections must be attested by the dated initials of the tenderer.
- Thee tenderer must provide PAN No. and VAT No. No of firm/company along with offer.
- The time allowed for completion of the job is **60 working days**. The same shall be reckoned from the date of issue of the work order.
- The tenderer may note that in case the work is awarded to him, he has to produce police verification certificate for the employees to be deputed for the work inside the BARC/BRIT complex, Navi Mumbai.
- The acceptance of the tender rests upon the undersigned with a right to reject the tender without assigning any reason.
- Income-Tax and surcharge on income-tax as applicable shall be deducted from the bill. The payment for the work done shall be paid by our Accounts Division only on satisfactory completion of the work within one month.

Free Issue Material:

There is no FIM for this work.

Site Visit

If the contractor wishes to visit the site to comprehend the scope of work the same will be arranged by the undersigned. The site can be visited on working days between 10.00 hrs to 15.00hrs. However, for site visit prior intimation of at least three working days is necessary for arranging the entry permits.

Supplier shall use all relevant standard material for this work.

Annexure-1

Scope of work for Repairing existing aluminum shutters at PMD, BARC, Vashi Complex, Navi Mumbai.

1. Total No. of aluminum shutters: 22 Nos.
2. Size of the shutter: 7 ft X 3 ft.
3. After dismantling the aluminum frames, a teakwood batten shall (2X1inch) to be inserted in each hollow aluminum section of door frames and shutter.
4. The shutter and frame shall be refitted.
5. All frame work shall be refabricated with new screw & fasteners.
6. The door shall be reinstalled with proper alignment.
