- a. The value of contract is ₹71,28,000/- (Rupees Seventy-One Lakh Twenty-Eight Thousand Only). This is inclusive of GST (at the prevailing rate of 18%), all other taxes, duties, levy or cess, fee, royalty charges etc.
 - b. TDS under GST: As per the government of Karnataka notification No. (18/2018) FD 47CSL2E17 Dt. 14.09.2018. Tax deduction at source (TDS) under GST has been implemented in the state of Karnataka W.E.F 01.10.2018. TDS @ 2% i.e., 1% CGST and 1% SGST for intra state and 2% IGST for interstate procurement will be deducted from your bill.
 - c. Income tax @ 2% or as applicable shall be deducted from each bill.
 - d. Any other taxes /cess as per Government directives shall be deducted from each bill paid to the contractor, from time to time.
14. Contract shall pay EPF & ESIC of contract workers to concerned Department and submit a documentary evidence to BARC seeking reimbursement. After satisfactory verification of documents, BARC will reimburse the amount to contractor. However, maximum monthly wage of contract worker on which EPF will be reimbursed is Rs. 15,000/-. ESIC is not reimbursable, if the monthly wage of contract worker exceeds Rs. 21,000/-.
15. Security: You shall follow all the site security rules as may be framed from time to time and shall obtain Police Verification Certificate (PVC) for all workmen. The PVC shall be valid till completion of service contract.
16. Your security vetting by Department is being carried out, if not earlier done. In case of receipt of any adverse charter and antecedent remarks/ notification against you or your contract personnel, consequent to the security vetting, BARC reserves absolute right to terminate the contract forthwith without assigning reason/ show cause notice. Under the circumstance the contractor will have no right to claim good any losses/liability that may be incurred as consequence to the above action initiated by BARC. BARC also reserves the right to forfeit in part/full performance security and/ or security deposit in possession of the Government for failure on the part of the contractor to abide/adhere to the Security instruction issued by DAE/ BARC from time to time.
